This **Memorandum of Understanding** (hereinafter called as the 'MOU') is entered into on this the 15<sup>th</sup> day of February Two Thousand Twenty Two (15/02/2022),

**BETWEEN**

**Rayat Shikshan Sanstha's Shri Sadguru Gangageer Maharaj Science, Gautam Arts, Sanjivani Commerce College Kopargaon, Dist Ahmednagar Pin 423601, the First Party** (hereinafter referred as '**First Party**', the institution which expression, unless excluded by or repugnant to the subject or context shall include its successors - in-office, administrators and assigns)

**AND**

**Surytej Sanstha, Kopargaon, Dist: Ahmednagar - 423601, and represented herein by its Zonal/Divisional Head, Mr. Sushant Ghodake , Founder** (hereinafter referred to as "**Second Party**", company which expression, unless excluded by or repugnant to the subject or context shall include its successors - in-office, administrators and assigns).

(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party')

## WHEREAS:

- First Party is a Higher Educational Institution named:  
**Rayat Shikshan Sanstha's Shri Sadguru Gangageer Maharaj Science, Gautam Arts, Sanjivani Commerce College Kopargaon, Dist Ahmednagar Pin 423601**
- Second Party is an Educational Institution named:  
**Surytej Sanstha, Kopargaon, Dist: Ahmednagar - 423601,**
- The First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources, and provide each of them with enhanced opportunities.
- The Parties intent to cooperate and focus their efforts on cooperation within area of Skill Based Training, Education and Research.
- Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest.
- Maharashtra Sahitya Parishad, Branch-Kopargaon, is participating to prepare various curriculum based programmes, videos and study materials on different platforms for undergraduate and post graduate students.
- This participation on different platforms will enhance and strengthen their competence in the skills of Marathi Language and Literature information.
- The first level of learning will be in the form of introductory orientation of the students to locate their interests in Marathi language and literature. The students will be given training in workshops about how to develop their competence in the language skills by the Second Party.
- In the first step the students will be given practice to sharpen their language skills regarding Marathi language acquisition.
- Further steps will help the students to develop their keen interest and acquire subsequent levels of comprehension under guidance of experienced professionals.
- The students will get an opportunity to work in certain projects related to learning skills.
- Every year the level of the challenge and the projects will become higher and higher.
- Maharashtra Sahitya Parishad, Branch-Kopargaon will acquire sponsorship for financial requirements of the programmes, videos and study materials on different platforms with the help of participating schools, colleges and supporting government, academic, and private organizations.
- **Surytej Sanstha, Kopargaon, Dist: Ahmednagar** the Second Party is engaged in Business, publication, Skill Development, Education and R&D Services in the fields of *Marathi Language and Literature* and related fields.

- **Surytej Sanstha, Kopargaon, Dist: Ahmednagar** the Second Party is promoted by its Zonal/Divisional Head **Mr. Sushant Ghodake, Founder.**

**NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:**

**CLAUSE 1 CO-OPERATION**

- Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Institution** and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
- First Party and Second Party co-operation will facilitate effective utilization of the intellectual capabilities of the faculties of First Party providing significant inputs to Second Party in developing suitable teaching/training systems, keeping in mind the needs of the industry.
- The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

**CLAUSE 2 SCOPE OF THE MoU**

- The budding graduates from the institutions could play a key role in technological up-gradation, innovation and competitiveness of an industry.

Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.

- **Curriculum Design:** Second Party will give valuable inputs to the First Party in teaching/training methodology and suitably customize the curriculum so that the students fit into the social scenario meaningfully.
- **Research and Development:** Both Parties have agreed to carry out the joint research activities in the fields of **Marathi Language and Literature**.
- **Skill Development Programs:** Second Party has to train the students of First Party on the emerging technologies in order to bridge the skill gap and make them ready for job opportunities.
- **Guest Lectures:** Second Party has to extend the necessary support to deliver guest lectures to the students of the First Party on the Marathi Language and Literature.
- **Faculty Development Programs:** Second Party has to train the faculties of First Party for imparting language skill exposure/ training as per the requirement considering the National Occupational Standards in concerned sector, if available.
- Both Parties to obtain all internal approvals, consents, permissions, and licenses of whatsoever nature required for offering the Programs on the terms specified herein
- There is no financial commitment on the part of the **Rayat Shikshan Sanstha's Shri Sadguru Gangageer Maharaj Science, Gautam Arts, Sanjivani Commerce College, Kopargaon, Dist: Ahmednagar Pin 423601** the First Party to take up any program mentioned in the MoU. If there is any financial consideration, it will be dealt separately with proper guidance of Sanstha.

### **CLAUSE 3 INTELLECTUAL PROPERTY**

- Nothing contained in this MOU shall, by express grant, implication, estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

### **CLAUSE 4 VALIDITY**

- This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period **Surytej Sanstha, Kopargaon, Dist: Ahmednagar**
- the Second Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of **Training Partner** or

**Surytej Sanstha, Kopargaon, Dist: Ahmednagar**

- the Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU
- Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.

**CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES**

- It is expressly agreed that **First Party** and **Second Party** are acting under this MOU as independent contractors, and the relationship established under this MOU shall not be construed as a partnership. Neither Party is authorized to use the other Party's name in any way, to make any representations or create any obligation or liability, expressed or implied, on behalf of the other Party, without the prior written consent of the other Party. Neither Party shall have, nor represent itself as having, any authority under the terms of this MOU to make agreements of any kind in the name of or binding upon the other Party, to pledge the other Party's credit, or to extend credit on behalf of the other Party.

**CLAUSE 6 JURISDICTION**

Any divergence or difference derived from the interpretation or application of the MoU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at District Head Quarters of the First Party. This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction in the Courts of **AHMEDNAGAR**.






