3. Biocontrol,micronutrient and, Herbal Research Lab of "Ashwmedh Agritech" will be utilized, time to time for practical work, motivations and observation of the "College "students.

4. Emergency requirement of chemicals, reagents for "College" and "Ashwmedh Agritech" will be shared with give and take, return basis at the time in emergencies only.

Between the years 2017-2022 department of zoology has signed collaboration with three parties, Ashwamedh Agritech & Farm Solution Systems Kopargaon, Suprakruti Madhushala (Apiculture centre) Nashik and Deokar poultry farm, Takli to utilize the instruments, equipments, infrastructure, to perform research activities and sharing of knowledge between parties with mutual understanding.
