(First Party and Second Party are hereinafter jointly referred to as 'Parties' and individually as 'Party') as

WHEREAS:

Somaiya College of Arts, Commerce and Science, Kopargaon, Department & Research Centre in Political Science is a part of educational institute imparting education at undergraduate,postgraduate & Research levels.

- C) The Parties intent to cooperate and focus their efforts on cooperation within area of Student & Faculty Exchange, Employment Based Training, Education and providing Collaborative activities for research & extension.
- D) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutualinterests.

NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH IN THIS MOU, THE PARTIES HERE TO AGREE AS FOLLOWS:

CLAUSE 1: CO-OPERATION

1. Both Parties are united by common interests and objectives, and they shall establish channels of communication and co-operation that will promote and advance their respective operations within the **Institution** and its related wings. The Parties shall keep each other informed of potential opportunities and shall share all information that may be relevant to secure additional opportunities for one another.
2. Both Parties are co-operation will facilitate effective utilization of the intellectual capabilities of the faculty of First Party providing significant inputs to them in developing entrepreneurial mindset which help student to decided entrepreneurship as a career choice keeping in mind the needs of the educational institute, the Second Party.
3. The general terms of co-operation shall be governed by this MOU. The Parties shall cooperate with each other and shall, as promptly as is reasonably practical, enter into all relevant agreements, deeds and documents (the 'Definitive Documents') as may be required to give effect to the actions contemplated in terms of this MOU. The term of Definitive Documents shall be mutually decided between the Parties. Along with the Definitive Documents, this MOU shall represent the entire understanding as to the subject matter hereof and shall supersede any prior understanding between the Parties on the subject matter hereof.

CLAUSE 2: SCOPE OF THE MoU

1. The budding graduates from the institutions could play a key role in research activity, political & economically development of the country through establishing enterprises. Both parties believe that close co-operation between the two would be of major benefit to the student community to enhance their skills and knowledge.
2. **Curriculum Design:** First Party will give valuable inputs to the Second Party in designing teaching / training methodology and suitably customize the curriculum so that the students fit into the current entrepreneurial scenario being fully.

3. **Entrepreneurship Awareness Programme:** Both parties to extend the necessary support to conduct professional and employability awareness programme to the students.
4. Both Parties to obtain all internal approvals, consents and permissions of whatsoever nature required for offering the Programmes on the terms specified herein
5. There is no financial commitment on the part of the **both the parties**, if there is any financial consideration, it will be dealt separately.

CLAUSE 3: INTELLECTUAL PROPERTY

1. Nothing contained in this MOU shall, by express grant, implication, Estoppel or otherwise, create in either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copy rights and designs) of the other Party.

CLAUSE 4: VALIDITY

1. This Agreement will be valid until it is expressly terminated by either Party on mutually agreed terms, during which period **Rayat Shikshan Sanstha's Shri Sadguru Gangageer Maharaj Science, Gautam Arts & Sanjivani Commerce College, Kopargaon, Department of political science** is the First Party, as the case may be, will take effective steps for implementation of this MOU. Any act on the part of **Kopargaon Taluka Education Society's, K.J. Somaiya College of Arts, Commerce and Science, Kopargaon, Department and Research Centre in, of Political Science** Second Party after termination of this Agreement by way of communication, correspondence etc., shall not be construed as an extension of this MOU.
2. Both Parties may terminate this MOU upon 30 calendar days' notice in writing. In the event of Termination, both parties have to discharge their obligations.

CLAUSE 5: OBJECT

Both Political Science Departments agree to develop the following collaborative activities in the academic areas of mutual interest, on a basis of equality and reciprocity. The two Political science departments shall seek to promote:

A. Faculty/Staff Exchanges:

- The exchange of faculty to the mutual benefit of both institutions, Collaboration in teaching, research and development, and consultancy studies in the field of mutual interest,
- The exchange of academic materials and publications, Conducting lectures,
- Undertaking joint research,
- Attachment of staff for purposes of curriculum development and review, attendance of courses, upgrading of teaching and research skills, Participating in seminars, symposiums, and other types of academic discussions,
- Conducting study tours and joint consultancy work.

A specific plan will be worked out for each activity; setting forth detailed arrangements for collaboration will be agreed. Terms and conditions for each visit or an assignment or such exchange, including those concerning salary, travel funding, health insurance, and housing will be worked out between the departments. A separate agreement will be entered into giving such details including term of exchange of any intellectual property.

B. Student Exchange

Department of Political science of Rayat Shikshan Sanstha's Shri Sadguru Gangageer Maharaj Science, Gautam Arts & Sanjivani Commerce College, Kopargaon and Department of, Political science of Political science Kopargaon Taluka Education Society's, K.J. Somaiya College of Arts, Commerce and Science, Kopargaon. agree that student exchange will be guided by principles listed below A home institution refers to the institution where a student is a full-time student, and from where he/she is expected to graduate.

A host institution refers to an institution that receives a student for a brief period of time to undertake a pre-determined programme or research of study from Department of Political science

- Exchange students will be selected by mutual agreement between the home institution and the host institution.
- An exchange student will continue to be treated as full-time student at his/her home institution.
- An exchange student will be considered as full-time "exchange" student at the host institution.
- His/her programme of study at the host institution will be determined by mutual consultation between his/her academic advisor at the home institution and his/her "interim" academic advisor identified by the host institution.
- The host institution will evaluate an exchange student's performance in each course or module, award a letter grade or marks, and issue a letter to that effect. The home institution may award to the exchange student credits earned at a host institution, but only after the home institution has established correspondence between courses taken at the host institution vis-a-vis those offered at the home institution.
- If an exchange student has undertaken research, then the host institution will evaluate the exchange student's performance in the research, and issue a letter to that effect, together with a "report" of the research carried out. If an exchange student has undertaken research, then the home institution will take note of the performance evaluation and the technical report, and take steps in accordance with its own procedures.
- Department of Political science, of Rayat Shikshan Sanstha's Shri Sadguru Gangageer Maharaj Science, Gautam Arts & Sanjivani Commerce College, Kopargaon and Department and Research Centre in Political science, of Kopargaon Taluka Education Society's, K.J. Somaiya College of Arts, Commerce and Science, Kopargaon, agree to provide suitable accommodation and living expenses for student exchange.
- The exchange students will pay tuition and other fees at their home institution.

C. Other Areas:

- To exchange information on research and educational programs,
- To exchange information on teaching, learning material and other literature relevant to their educational and research programs,
- To jointly organize short-term continuing education programs on topics of mutual interest and to invite each other's faculty to participate therein,
- To organize jointly seminars, conferences, or workshops on topics of mutual interest and to invite each other's faculty to participate therein,
- To propose and engage jointly in research or training programs sponsored by funding agencies, and to invite each other's faculty to participate therein,
- To exchange, on a reciprocal basis, students at Undergraduate, Post Graduate level for limited periods of time for purpose of education.
- To permit students staff to use library facilities.

CLAUSE 7: LEGAL EFFECT

Nothing in this Memorandum shall be construed as creating any legal relationship between the departments. This Memorandum is a statement of intent to foster genuine and mutually beneficial collaboration.

CLAUSE 8:DISPUTE RESOLUTION

In case, there be a dispute relating to any aspect of academic cooperation, Head, Dept. of Political science, Department of Political science, of RayatShikshan Sanstha's Shri SadguruGangageerMaharaj Science, Gautam Arts &Sanjivani Commerce College, Kopargaon, Head Dept. of, Political science Department of Political science, of KopargaonTaluka Education Society's, K.J. Somaiya College of Arts, Commerce and Science, Kopargaonwill jointly resolve the dispute in a spirit of independence, mutual respect, andshared responsibility.
